



One World Government and Signs of the End

The United Nations Human Development Report (1994) has a section called “Global Governance for the 21st Century” which says: “Mankind's problems can no longer be solved by national government. *What is needed is a World Government.* This can best be achieved by strengthening the United Nations system.”

If the people who control the United Nations want a world government that is what you will get.

According to Bible prophecy at the time of the end “ten kings”, who are identified in Revelation 18:11 as “the merchants of the earth”, will set up a one world government that will last for “one hour” or “a little while” (Revelation 17:10,12). This world dictatorship will divide the world into ten economic regions and abolish all national governments and ethnic boundaries. Prophecy teaches shortly after the ten kings set up a one-world dictatorship; “they [will] give their power and authority to the beast.” (Revelation 17:13)

This prediction does not belong to the future; for years the *novus ordo seclorum* has been a hidden agenda but we are at a trigger point where *a planned collapse of the world economy will bring it to completion.*

The average citizen has no idea the world economy is tilted precariously on a precipice and that a *massive economic wipe out unrivalled in world history is an absolute certainty.* Who wants to be told the world monetary system is a heartbeat away from complete disintegration? But Bible prophecy is being fulfilled.

“The biggest concern today is the growing constituency for instability ... *so that the eventual breakdown of freely floating exchanges is ensured,*’ ... [T]here are many more people now who have an interest in profiting from instability; previously, they had an interest in stability. *If you have an unstable system, it is just a question of when it will fly off the handle. It will blow apart at the moment when the US dollar experiences a crisis. When the dollar crisis occurs, the world will have no system left.* (Michel Chossudovsky Professor of Economics, University of Ottawa, author of *The Globalisation of Poverty: Impacts of IMF and World Bank Reforms*, Third World Network, Penang and Zed Books, London, 1997)

Why does prophecy say, “no one will be able to buy or to sell?” (Revelation 13:17) *The reason is private access to everything necessary to sustain life has been eliminated.* In the New World Order just over the horizon whether you eat or not, live or die will be determined by your usefulness to a despotic hierarchy.

In 1970 Zbigniew Brzezinski, (*Between Two Ages: America’s Role in the Technetronic Era*) wrote,

“It will soon be possible to assert almost continuous control over every citizen and to maintain up-to-date files containing even the most personal details about health and personal behavior of every citizen, in addition to the more customary data. These files will be subject to instantaneous retrieval by the authorities. Power will gravitate into the hands of those who control information.”

According to one theory a powerful elite are employing massive resources to create a society under their control in which a compulsory bio chip implant will determine your entire material existence.

“At a global security conference held today in Paris, an American company announced a new syringe-injectable microchip implant for humans, designed to be used as a fraud-proof payment method for cash and credit-card transactions. In his speech today at the ID World 2003 conference in Paris, France, Scott

R. Silverman, CEO of Applied Digital Solutions, called the chip a 'loss-proof solution' and said that *the chip's 'unique under-the-skin format' could be used for a variety of identification applications in the security and financial worlds.*" (Sherrie Gossett, WorldNetDaily.com, November 21, 2003)

"Novartis implanted computer chips into the shoulders of 20 patients taking the blood pressure drug Diovan; *the chips sent text messages to their cellphones* when it was time to take the next pill. ... Novartis' efforts are doubly creepy because it actually involves *two* internal chips. The first chip is inside the pill being swallowed. It sends a signal to the chip in your shoulder. *If you fail to take your next pill, the shoulder chip nags you on your mobile.*" (See Internet, *Novartis Chip Implant Texts Your Phone*)

One-world Government

On September 17 1973 The Club of Rome, a front organization for world bankers, the persisting architects of a one world government, issue a report authored by Mihajlo Mesarovic and Eudard Pestel.

A summary of the report by Mesarovic and Pestel Peccei states that the Club of Rome planned for a "world model, based on new developments of the multilevel hierarchical systems theory, [which] divides the world *into ten interdependent and mutually interacting regions of political, economic or environmental coherence.*" (Gary Kah, *En Route to Global Occupation* Huntington House 1992 p.41)

The "ten kings" are identified in Revelation 18:23 as "the merchants [and] great men of the earth." These "merchants of the earth" have made public their plan to divide the world into ten economic regions.

The plan to abolish national governments and divide the world into economic zones was first proposed in 1942 by the Carnegie International Endowment for Peace, an agency for *novus ordo seclorum*. In 1942 Stalin presented the same version of regionalism as his model for the Union of Soviet Socialist Republics.

"Divide the world into regional groups *as a transitional stage to world government*. Populations will more readily abandon their national loyalties to a vague regional loyalty than they will to a world authority. *Later, the regions can be brought all the way into a single world dictatorship.*" (Josef Stalin, *Marxism and the National Question*, 1942 <http://archives.lists.indymedia.org/imc-nyc/2004-April/004905.html>)

With Stalinist Russia as the prototype we do not have to guess what the New World Order will be like.

On Oct. 29, 1991 David Funderburk, former U.S. Ambassador to Romania, told a North Carolina audience: "George Bush has been surrounding himself with people who believe in one-world government. *They believe that the Soviet system and the American system are converging.*"

Eliminating the United States as a sovereign nation and converting Canada, the United States and Mexico into a politically impotent bureaucracy (with one currency), called the North American Union, has become a fixation of world bankers and leading US politicians, including presidents of the United States.

"What I am trying to do is *to promote a process of reorganization of the world*. ... If we can prove that you can merge integrated economies and integrated democracies, *then we'll be more likely to build a global system.*" (Bill Clinton, The Phyllis Schlafly Report, <http://www.eagleforum.org/psr/2002/feb02/psrfeb02.shtml>)

The problem with Clinton's *economic model* is that it is a replication of Stalin's *political model*.

"One of the Clinton administration's primary goals [was] ... creating a new homogeneous economic region of the Americas that would encompass nearly 800 million people. ... *Combining countries under*

more easily managed regional authorities, regionalization, is the key to governing the world. Any detailed track record of these international trade agreements was covered up to keep the truth of their effects hidden from the public.” (Ted Flynn, *Hope of the Wicked, The Master Plan to Rule the World*, p.174)

At Baden Baden Germany, June 5, 1991 David Rockefeller delivered the following illuminating address.

“We are grateful to The Washington Post, the New York Times, Time Magazine, and other great publications whose directors have attended our meetings and respected their promises of discretion for almost forty years. It would have been impossible for us to develop our plan for the world if we had been subject to the lights of publicity during those years. *But the world is now more sophisticated and prepared to march towards a world government. The supranational sovereignty of an intellectual elite and world bankers is surely preferable to the national auto-determination practiced in past centuries.”*

Revelation 17

In a parallel prophecy to Revelation 17:12 *Daniel 11:38-39* speaks an end time ruler identified as the “King of the North” (Paul’s Man of Sin) who, when he comes into power; “will greatly honour those who acknowledge him. *He will make them rulers over many people and will distribute the land at a price.”*

Revelation 17:13 tells us the ten kings will “give their power and authority to the beast” and the “Beast” will emerge as the *numero uno*. He will be backed up by frightening paranormal forces (Revelation 16:13) who will perform miracles in order to establish his authority. (Daniel 11:39) As a reward for their collaboration the Beast will distribute the land among the ten kings and make them co-rulers for “a price.”

What is intended by this synthesis of evil forces is a “bureaucratic collectivist one-world government” and “scientifically-managed world state and socialist economy.” In reality it will be a punitive, fascist dictatorship in which everybody will have only one right - the right to do exactly what they are told.

Whereas a world government at a political level has not been fully achieved, *a one-world integrated economic system is a present a reality*. National economic independence does not exist. Every nation to some extent represents occupied territory on the basis of its monetary dependence on world bankers.

“[T]he powers of financial capitalism had another far-reaching aim, *nothing less than to create a world system of financial control in private hands able to dominate the political system of each country and the economy of the world as a whole*. This system was to be ... controlled by the world's central banks_which were themselves private corporations...” (Carroll Quigley, *Tragedy and Hope*, p.324)

“This manipulation of market forces by powerful actors constitutes a form of financial and economic warfare. No need to recolonise lost territory or send in invading armies. *In the late 20th century, the outright 'conquest of nations', meaning the control over productive assets, labour, natural resources and institutions, can be carried out in an impersonal fashion from the corporate boardroom: ...* The relevant data are instantly relayed to major financial markets - often resulting in immediate disruptions in the functioning of national economies.” (Report, Group of 15, Malacca, Nov. 3 1997, South China Morning Post)

“There are 193 nations in the world, many of them ostensibly democratic, but most of them are dwarfed by the corporations that alone decide what will be produced and where and how much people will be paid to do the work. *In effect, these multinational enterprises have become a ... covert world government.”* (Someshwar Singh, *Free Global Economic from Corporate Highjackers*, <http://www.twinside.org.sg/title/jackers.htm>)

The philosophy behind the New World Order is explained as follows. “Hegel taught that history moves faster toward its conclusion by way of warfare, *so evolutionary socialists were taught by Hegel to see struggle as the precipitant of evolutionary improvement for the species*, a necessary purifier eliminating

the weak from the breeding sweepstakes. Society evolves slowly toward 'social efficiency' all by itself; society under stress, however, evolves much faster! *Thus the deliberate creation of crisis is an important tool of evolutionary socialists.*" (The Open Conspiracy <http://www.johntaylorgatto.com/chapters/9f.htm>)

Every political and economic crisis for the last one hundred years has been a human invention. The "big" one is next. At the UN (Sept. 23, 1994) David Rockefeller declared: "We are on the verge of a global transformation. *All we need is the right major crisis, and the nations will accept the New World Order.*"

The Serpent

In his 1928 book *The Open Conspiracy* H. G. Wells declared that, "The political world of the Open Conspiracy (NWO) *must weaken, efface, incorporate, and supersede existing governments.* ... The character of the Open Conspiracy will now be plainly displayed. *It will be a world religion.*"

The one world government will not only be based on the politics of socialist's principles (the bureaucracy owns everything, including the people) but also on occult practices linked to ancient Babylon. Scripture is explicit that the NWO will be structured on religion, "they *worshiped* the dragon." (Revelation 13:4)

The reference to the "dragon" in Revelation 12:9 is a mistranslation; the correct translation of "*drakôn*" is "serpent." "The great *drakôn* was thrown down, the *serpent* of old who is called the devil and Satan."

In Greek *drakôn* (δρακων) means "snake", in the LXX *drakôn* is synonymous with the noun *ophis* which means "snake." The constellation "*drakôn*" is referred to in *Job* 26:13 and in *Isaiah* 27:1 as "the crooked serpent." In ancient Persian mythology "*drakôn*" was a serpent deity called Azhdeha. In Greek mythology "*drakôn*" was a hundred-headed serpent in the Garden of Hesperides that was killed by Hercules.

In rabbinic writings the "serpent" is the enemy of God's people. "The targumic tradition links serpents and scorpions with Satan and evil spirits." (Graig Evans, *Ancient Texts for New Testament Studies* p.4) The early Christians identified *drakôn* as the serpent who tempted Adam and Eve in the Garden of Eden.

The understanding that in Revelation 13 *drakôn* refers to the "serpent" (not dragon) is essential to a correct interpretation of the prophecy. Prophecy identifies the apostasy as 'Babylon', and that is another key to understanding the prophecy. Babylon's chief deity was Marduk *the serpent deity*. One of Marduk's fifty names was "Nibiru" or "Nebiru"; in Egypt "Neb-Heru" was the "Lord of the sun." The intended meaning of *drakôn* is that the last battle between good and evil will be a war between the serpent sun god (Satan) and the risen Jesus in an attempt to eliminate the knowledge of the true God from the earth.

When the focus in prophecy is put on the people of God and their earthly struggle the biblical paradigm is lost. The backdrop to the Apocalypse is cosmic warfare and a final showdown between Christ and Satan.

"Then I saw the beast and the kings of the earth and their armies gathered together to make war against the rider on the horse and His army. But the beast was captured, and with him the false prophet who had performed the miraculous signs. ... The two of them were thrown alive into the fiery lake of burning sulfur. The rest of them were killed with the sword that came out of the mouth of the rider on the horse, and all the birds gorged themselves on their flesh. ... And the devil, who deceived them, was thrown into the lake of burning sulfur, where the beast and the false prophet had been thrown. ... Then death and Hades were thrown into the lake of fire. The lake of fire is the second death. If anyone's name was not found written in the book of life he was thrown into the lake of fire." (Revelation 19:17-21, 20:10, 14-15)

An eschatological conflict between *drakôn* the "Sun God" and the Creator (Revelation 14:7) has reference to worship *in which personal spirituality is a big issue*. The challenge in the days of Elijah; "If the Lord is God, follow Him; if Baal, follow him" (1Kings 18:21) will become a final ultimatum for all.
