



The Pope, World Bankers and Goddess Worship

The correct approach to Scripture as defined by the Scriptures is the recognition that the biblical testimony has the force of God speaking. In this understanding the written word is to be accepted as the spoken words of deity. The Hebrew title for Scripture is Torah which corresponds to the notion of instruction. In this sense the written Torah irrespective of its human element is meant to stand in the consciousness of the people as God Himself speaking and imparting personal instruction.

The Torah is not a record of a history of God from the human side; it is a record of Gods encounter with humanity as God Himself sees it. The Torah offers a synthesis of the past and the present. And just as Torah history is not open to modification likewise God's account of the future does not allow for experimentation. The Torah imposes on us an irreducible claim to teach Bible prophecy correctly, as much as other parts of the Torah, because prophecy is "the testimony of Jesus." (Revelation 1:2)

The Scriptures alone, in their totality, have an absolute primacy in the practice of Christianity. To be counted as a disciple we must accept everything they teach, unconditionally, and without exception. The Scriptures stand above all the opinions of the fathers, totally and always, whoever they might be.

These days at every level of power politics a World Government is promoted as something necessary and inevitable. At a Bilderbergers Conference held in Germany June 1991 David Rockefeller told an assembly of the world's power brokers; "The world is now more sophisticated and prepared to march towards a world government" under the control of "an intellectual elite and world bankers."

The promotion by a world banker of a "world government" controlled by world bankers is not something to be treated with indifference. The interesting thing about Rockefeller's presentation is it comes two thousand years after Bible prophecy presented a summary of his Bilderbergers speech.

"The ten horns you saw are **ten kings** who have not yet received a kingdom but who **for one hour** will receive authority as kings along with the beast." (Revelation 17:12)

These "ten kings" are identified in Bible prophecy as "kings of the earth", "merchants of the earth", and the "world's great men."¹ We are told these "merchants of the earth" will set up their own autocratic world government. We know the "merchants of the earth" as world bankers. Accordingly, when a leading world banker advocates a world government under control of world bankers, without him knowing it, he is fulfilling his part in a prophecy about world bankers. (¹Revelation 18:9, 11, 23)

On September 17 1974 the Club Of Rome issued a report by Mihajlo Mesarovic and Eudard Pestel entitled "Regionalized and Adaptive Model of the Global World System". This report outlined plans by World Bankers, and others, to divide the world into ten economic regions. A summary of Mesarovic and Pestel's "Regionalized and Adaptive Model of the Global World System" says;

"Their world model, based on new developments of the multilevel hierarchical systems theory, **divides the world into ten interdependent and mutually interacting regions of political, economic or environmental coherence.**" (Aurelio Peccei, President, Club of Rome, Mankind at the Turning Point (New York: E.P. Dutton & Co Inc, 1974), pp.9-10)

Note that the prophecy in Revelation 17:12 has specific numerics; in the endtime there will be “**ten kings**” who will function as world rulers for a short time. The plan devised by the Club of Rome divides the world into “**ten interdependent and mutually interacting regions**” under the iron fisted control of “merchants of the earth” who are described in Revelation 18:9 as “kings of the earth.”

This is no obscure prophecy, its details are precise. In the last days the “merchants of the earth,” that is, those who control the world commerce and financial structures will become “kings of the earth.”

“The powers of financial capitalism had another far-reaching aim, **nothing less than to create a world system of financial control in private hands able to dominate the political system of each country and the economy of the world as a whole.** This system was to be controlled in a feudalist fashion by the central banks of the world acting in concert by secret agreements arrived at in frequent private meetings and conferences. The apex of the system was to be the Bank for International Settlements in Basle, Switzerland, a private bank owned and controlled by the world's central banks which were themselves private corporations ...” (Carol Quigley, *Tragedy and Hope* p.324)

The World Bankers first laid plans to set up a one-world-government 329 years ago. “In 1773, Mayor Amschel Rothschild had a meeting in Frankfurt, Germany ... **Most [attending] were international bankers.** On 1 May, 1776, [Adam] Weishaupt created a secret organization with their funds, named the Order of the Illuminati. **The ultimate goal of the Illuminati is to create a New World Order.**”

“In 1791, John Robison ... described the diabolic plans, which he found out by infiltrating the Freemasonry, of the New World Order, and the role of Adam Weishaupt and the Illuminati. **He claimed the NWO plans will be realized by those who control the international banking system.**”

Why the long delay? Because in God’s intention the Bankers time had not yet come. It is God alone who “who changes the times and the epochs; He removes kings and establishes kings.”(Daniel 2:21)

The theme of the World Bankers, which articulates their methodology, is Ordo ab Chao (order out of chaos.) They were responsible for the French Revolution; despotic British Imperialism was a creation of the Bankers to increase their profit. Moses Mordecai Marx Levi, (Karl Marx) was a member of the “League of the Just,” a creation of the Bankers. They created the Great Depression by withdrawing their money from circulation. The World Bankers have been a driving force in every major military conflict, sometimes supporting both sides. Every war has ended as they planned it.

El Fin del Dinero

The quest for a “novus ordo seclorum” by Bankers has never been a secret to people in high places. Influential individuals have been warning about a world dictatorship by World Bankers for years.

“If the American people ever allow private banks to control the issue of their currency, first by inflation and then by deflation, the banks and corporations that will grow up around them will deprive the people of all property until their children wake up homeless on the continent their fathers conquered.” (Thomas Jefferson, President of the United States 1801-1809)

“Since I entered politics, I have chiefly had men's views confided to me privately. Some of the biggest men in the United States, in the Field of commerce and manufacture, are afraid of something. They know that there is a power somewhere so organized, so subtle, so watchful, so interlocked, so complete, so pervasive, that they better not speak above their breath when they speak in condemnation of it.” (Woodrow Wilson, President of the United States, 1913 - 1921)

“From the days of Spartacus, Wieskhopf, Karl Marx, Trotsky, Rosa Luxemburg, and Emma Goldman, this world conspiracy has been steadily growing. This conspiracy played a definite recognizable role in the tragedy of the French revolution. It has been the mainspring of every subversive movement during the 19th century.” (Winston Churchill 1922)

The current world economic crisis is no accident of history or mere collective example of fiscal incompetence, it is the means of transition into the New World Order. It is part of a plan centuries old. What is now taking place in world history represents what the biblical writers wrote about and refer to as the “time of the end.” The “end time” *is no longer future*; it is embedded in the present.

In an address to the UN David Rockefeller indicated the world bankers are formulating a cataclysmic event. “All we need is *the right major crisis*, and the nations will accept the New World Order.”

The World Banker’s planned to bring in the One World Government in the year 2000 to coincide with the New Millennium. Two or three other dates have also been set, but for reasons detailed in Revelation 7:1 they were thwarted by divine intervention. They have once again set a specific time.

The method chosen to initiate the New World Order is the collapse of the world monetary system (el fin del dinero). Whereas it is possible to do away with cash and operate an electronic banking system *the instant world-wide collapse of the monetary system will have catastrophic effects on the world food supply*. According to prophecy just before Jesus returns the entire world will experience “death, mourning and famine.”¹ Prophecy says many will die. A world famine caused by the collapse of the world food supply may be the cause that limits the New World Order to “one hour.” (¹Rev. 18:8)

Whereas the endtime One World Government will only last for “one hour” of prophetic time Daniel 12:1 indicates that the “one hour” is going to be a concentration of horrors. “There will be a time of distress such as has not happened from the beginning of nations until then.” However, when the Bankers New World Order disintegrates cosmic forces will replace it with their own occult World Religion centered on Satan impersonating Jesus and the worship of the “Queen of Heaven.” Mark 13:20 defines the ethos of the times. “If the Lord does not cut short those days, no one will survive.”

Goddess Worship

The central element in endtime prophecy is cosmic warfare between “spirits of demons performing miraculous signs”¹ and Jesus which will determine our destiny. Paul says; “our struggle is not against flesh and blood but against the spiritual forces of evil in the heavenly realm.”² Concerning this war Jesus’ declared that “*He who is not with Me is against Me.*” (¹Rev. 16:14, ²Eph. 6:12, ³Matt. 12:30)

In reference to this warfare Daniel 11:36-39 says the “king of the north” will worship “the god of fortresses.” With assistance from this deity we are told, “He will attack the mighty fortresses with the help of a foreign god.” The Hebrew text has no chapters so the timeframe for the appearance of “the god of fortresses” is identified in Daniel 12:1 as central to the final eschatological events.

To confirm the identity of the “the god of fortresses” we need to establish the identity of the “King of the North.” In the experience of Israel the “King of the North” was the king of Babylon. (2Kings 25:1-28) The historical deity known in Babylon as “the god of fortresses” was Sammu-amat or Semiramis who was exalted to the status of a goddess and worshipped as “the goddess of towers.”

Semiramis was known as the “goddess of towers” because of her distinct architectural contribution.

“Semiramis was forced to build a system of walls and towers ... around Babylon to defend herself. She was the first to build fortifications and her crown afterwards was in the form of the turreted walls of Babylon. To oppose the accusations of ‘mere’ womanhood laid against her, she had herself deified ... and installed as The Queen of Heaven.”(Bryce Self, Semiramis, Queen of Heaven)

Israel worshipped “the goddess of towers” under the name of Astarte. ***“The children gather wood, the fathers light the fire and the women knead the dough and make cakes to offer to the Queen of Heaven. They pour out drink offerings to other gods to arouse My anger.”*** (Jeremiah 7:18-20)

According to prophecy just as ancient Babylon worshipped the “Queen of Heaven” so also eschatological “Babylon” will enforce the world-wide worship of the “Queen of Heaven.” The “Queen of Heaven” has multiple manifestations: Anta, Aphrodite, Artemis, Astarte, Brigid, Ceres, Demeter, Diana, Easter, Freya, Gaia, Hera, Ishtar, Isis, Juno, Kali, Minerva, Persephone and Venus.

“All the major religions are expecting the return of a religious teacher who will inaugurate a new age in religion. Hindus’ await the coming of Kalki avatar or Krishna, Shia Muslims the Imam Mahdi, Jews the Messiah, Zoroastrians the Saoshyant, Buddhists expect the Maitreya and Christians the return of Jesus. ***Among themselves these religions offer no hope of unity but prophecy teaches ultimately they will unite in the common worship of the Great Goddess and Earth Mother.”***

The evidence points in one direct – the endtime “Great Goddess and Earth Mother” is the Roman Catholic Mary. Numerous popes tell it that way and spirits from the dark side also tell it that way.

“Among all the women who have ever lived, the mother of Jesus Christ is the most celebrated the most venerated. ... Among Roman Catholics, the Madonna is recognized not only as the Mother of God, ***but also, according to modern Popes, as the Queen of the Universe, Queen of Heaven*** ... and even the Spouse of the Holy Spirit.” (Time Magazine, Handmaid or Feminist? Dec. 30, 1991)

“The same worship is rendered to Mary as to Christ. ... ***To her prayers are addressed as to a divine being, and blessings are asked as from one, who has power to bestow them.*** ... In Roman Catholic countries the dawn is ushered in with hymns to her honour; her praises are again chanted at noon, and the day is closed with an Ave Maria sung to the Lady of Heaven.” (James Wylie, The Papacy: Its History, Dogmas, Genius, and Prospects, p. 370)

According to John Paul, II (Vatican Information Service, May 7, 1997) belief in Mary as the “Queen of Heaven” means, “Marian ***worship*** in the ecclesial community ... is based on the will of Christ.”

From the perspective of the papacy the mediator between heaven and earth is not Jesus, but Mary.

“After my election as Pope, as I became more involved in the problems of the universal Church, I came to have a similar conviction: On this universal level, if victory comes it will be brought by Mary. ***Christ will conquer through her, because he wants the Church’s victories now and in the future to be linked to her.***” (Pope John Paul II, Crossing The Threshold of Hope, pp. 220, 221)

Pope Pius IX said, ***“Our salvation is based upon the holy Virgin... so that if there is any hope and spiritual healing for us we receive it solely and uniquely from her.”***¹ “With reason, then, does St. Laurence Justinian call her [Mary] ‘the hope of malefactors,’ ***since she alone is the one who obtains them pardon from God.*** ... (¹Encyclical of February 2, (1849) Vol. 1, p.196, ²St. Alphonsus Liguori, The Blessed Virgin Mary, Tan Books, 1982 p.52)

Spirits of Demons Performing Signs

According to Scripture the entire world will soon be deceived by “lying signs and wonders,”¹ and by “spirits of demons, performing signs, which go out to the kings of the whole world, to gather them together for the war of the great day of God, the Almighty.”² (¹2Thessalonians 2:9, ²Rev.16:14)

The following text contains a decipherable code and understanding the code interprets the prophecy.

“Then I saw three evil spirits that looked like frogs; they came out of the mouth of the dragon, out of the mouth of the beast and out of the mouth of the false prophet. They are spirits of demons performing miraculous signs, and they go out to the kings of the whole world, to gather them for the battle on the great day of God Almighty.” (Revelation 16:13-14)

The imagery of “three evil spirits that looked like frogs” is our key. The Egyptian Goddess Heket (or Heqet) was represented in the form of a frog or as a woman with a frog’s head. *So far as the symbolism goes Heket was the goddess who proclaimed the enthronement of Horus the sun god.* Accordingly, the three unclean spirits “like frogs” in symbolic terms link a goddess to the enthronement of a false Messiah (Christos). The false Christ worshipped in Revelation 13:4 is Satan.

“They worshiped the serpent (drakôn) for he had given his authority to the beast.” Reference to serpent “worship” indicates at the end time Satan will present himself to be worshipped as “Christ.” As Christ he will syncretize his worship with the worship of “the Great Goddess and Earth Mother.”

Prophecy says the end time leader of Babylon “will attack the mighty fortresses with the help of a foreign god.” Scripture indicates *in what is soon to come* “the Great Goddess and Earth Mother” will provide a world-wide public manifestation of her power through “terrifying signs in the heavens.”

“Do not learn the way of the nations, *and do not be terrified by the signs of the heavens.* Although the nations are terrified by them.”¹ “There will be great earthquakes, and in various places famines and pestilences. *And there will be terrors and great signs from heaven.*”² (¹Jer.10:2, ²Luke 21:11)

“The end is very near. We who know the truth should be preparing *for what is soon to break upon the world as an overwhelming surprise.*”¹ “*Fearful sights of a supernatural character will soon be revealed in the heavens.* ... The spirits of devils will go forth to the kings of the earth and to the whole world, to fasten them in deception, and urge them on to unite with Satan in his last struggle against the government of heaven.” (¹RH, Sept. 10, 1903, ²GC p.624)

The Marian apparitions are also recycling Jesus’ warning of “terrors and great signs from heaven.”

“Soon, I [Mary] will come, my children! *Soon, I will be in your midst with a great light.* ... *I will pass above everyone in a cloud and everyone will see me.* ... *I will give a great sign in the sky for those who will still want to be saved.* All those who have recourse to me who have a look of repentance, this will be sufficient to save them.” (Timothy Beckley & Art Crockett, Secret Prophecy of Fatima Revealed, pp. 106, 107)

“I wish to also tell you that before my apparitions end completely ... *I will be seen among all people, not for just a moment, but everyone will have a chance to see me.* As I appeared in Zeitoun, [visibly in the sky] I shall appear again so everyone may see me.”(Cited Queen of Rome, Queen of Islam, Queen of All)

A Goddess for All

In Roman Catholic teaching Genesis 3:15 is referred to as the protoevangelium, which means the first prophetic reference to Jesus. The text reads; “I will put enmity between you and the woman, and between your offspring and hers; **He** will crush your head and you will strike **His** heel.” However, in the Catholic Douay-Rheims version the text has been rewritten as a reference to Mary and says;

“I will put enmities between thee and the woman, and thy seed and her seed: ***she shall crush thy head, and thou shalt lie in wait for her heel.***”(Genesis 3:15)

Louis de Monfort claims that in her heavenly role in religion Mary embodies the most concentrated presence of God in the entire universe: “Mary is the sanctuary and the repose of the Holy Trinity, where God dwells more magnificently and more divinely than in any other place in the universe.”

In the current paradigm of the Roman Catholic Church Mary has assumed the functional role of deity. In this way the central role of Jesus in human redemption has been transferred from Jesus to Mary. For some the Roman Catholic Mary stands for everything Jesus stands for in His absence.

“Mary is not only the recipient of extraordinary gifts from the Trinity; ***she is also a giver of extraordinary gifts from them.*** ... There is no greater grace after the Son’s incarnate grace ***than Mary’s gift of herself to those called to be the brothers and sisters of Jesus.***”

In his first speech as Pope, delivered on April 20 to the College of Cardinals gathered in the Sistine Chapel, Benedict XVI said: “In support of this promise, ***I invoke the maternal intercession of Mary Most Holy, in whose hands I place the present and the future of my person and of the Church.***” (Benedict XVI, a Pope of Christ, Communion, Collegiality, Vatican Information Service, April 20)

The Marian apparitions claim to be preparing the way for the coming of “Jesus.” 2Cor. 11:4 speaks of “another Jesus,” so which “Jesus” is it? The Thunder of Justice (p.12) says; “As John the Baptist prepared the way for the first coming of Jesus Mary prepares the way for His Second Coming.”

According to “Mary” God has assigned her the role as co-worker and the earthly representative of the entire heavenly Trinity. “Until I am acknowledged there where the Most Holy Trinity has willed me to be, ***I will not be able to exercise my power fully, in the maternal work of co-redemption and of the universal mediation of graces.*** ... ***let yourselves be transformed by my powerful action as Mother, Mediatrix of Graces and Co-redemptrix.***” (Jim Tetlow, Will Mary Unite All Religions?)

“In many ways, the 20th century has belonged to Mary. From almost every continent, visionaries have reported more than 400 ‘apparitions’ of the Virgin - more than in the previous three centuries combined. ***Taken together, these visions point to what the Marian Movement believes is a millennial ‘Age of Mary.’***” (Kenneth L. Woodward, “Hail, Mary,” Newsweek, Aug. 25, 1997, p. 50)

“When he was made a bishop in 1958, John Paul ... chose as his Latin motto Totus Tuus (All Yours) - referring to Mary, not Christ ... ***John Paul made Mary’s unifying power a centerpiece of his papal arsenal.***” (Time Magazine, Handmaid or Feminist?, December 30, 1991)

In the ecumenical paradigm “Mary” is employed not only by Roman Catholic sources, but also by impersonating fehlergeist, to make the “Queen of Heaven” the primary deity in worship. Every religion that has a female deity or a revered female entity is being drawn to the “Queen of Heaven.”

“More than 18 million people have traveled to the tiny Bosnian Village of Medjugorje to witness daily apparitions of the Virgin Mary and experience her healing powers. ... ***Mary is not only present but ‘everyone’s goddess,’ a culmination of the sacred feminine throughout history who loves and nurtures all of humanity. ... the Virgin Mary of today is really a composite figure of all the Goddesses that went before her and taps varied viewpoints to capture the whole tradition from which Mary springs.***” (Book Review, A Mother Goddess for Our Times)

“It’s not news that Muslims revere Mary as a pure and holy saint - she’s mentioned 34 times in the Koran, ***but to see large numbers of Muslims making pilgrimages to Christian Marian shrines is a remarkable thing.***”(Robert Sullivan, The Mystery of Mary, Life Magazine, Dec.1996, pp.45, 58, 60)

“I believe the Blessed Virgin chose to be known as Our Lady of Fatima as a pledge and a sign of hope to the Moslem people, and as an assurance that they, who show her so much respect, will one day accept her divine Son, too. ***Mary is the portal for Moslems to accept Christ.*** ... It is our firm belief the fears some entertain concerning the Muslims are not to be realized, but that Islam, instead, will eventually be converted to Christianity and in a way that even some of our missionaries never suspect. ***It is our belief this will happen not through the direct teaching of Christianity but through a summoning of the Muslims to a veneration of the Mother of God.***” (Bishop Fulton Sheen)

Enden

According to prophetic indicators based on a dispassionate analysis of the “signs of the times” the entire planet is on the verge of an entry into what Scripture describes as “the ‘time of distress such as has not happened from the beginning.’”¹ It will be a catastrophe to be endured from which there is no possibility of escape but one in which the absolute supremacy of God will be revealed.(¹Daniel 12:1)

“The ‘time of trouble such as never was,’ is soon to open upon us; and we shall need an experience which we do not now possess, and which many are too indolent to obtain. ***It is often the case that trouble is greater in anticipation than in reality; but this is not true of the crisis before us.*** The most vivid presentation cannot reach the magnitude of the ordeal. In that time of trial, every soul must stand for himself before God.” (GC p.623)

As bad as it might be there will be no overwhelming surprises for the true believer. The moral power of those who have been baptized into the Spirit of Christ, and in whom Jesus dwells as their higher self, will confront centuries of the accumulated power of evil and defeat it. It will be a costly victory for the visible church, corporate Christianity will be obliterated and only a small remnant of those who today profess faith in Jesus will survive. In God’s eternal plan that is not how it is meant to be.

In the final conflict Jesus will make His people invincible in moral conflict and impervious to sufferings by giving them a revelation of Himself. This revelation will not be a cognitive encounter but will be a sensory immersion into the dynamics of Deities boundless love for a fallen humanity.

“And I will pour out on the house of David and the inhabitants of Jerusalem a spirit of grace and supplication. ***They will look on Me, the one they have pierced, and they will mourn for him as one mourns for an only child, and grieve bitterly for him as one grieves for a firstborn son.***”
(Zechariah 12:10)

“O people of Zion, who live in Jerusalem, you will weep no more. How gracious He will be when you cry for help! As soon as He hears, He will answer you.” (Isaiah 30:19)
